1.	Metal cast brass pillar (size 14" high) in gold plated etching suitably with National Safety Awards, logo and year of award 2015 on top in round shape on metal disc in silver plated. Ashoka lion & DGMS logo duly etched with two colours all lacquered mounted on teak wood base with name plate duly etched in colour, all put in one acrylic (transparent fibre) cover & supplied in Hardboard Box [Shield Sample at Page-4] .
2.	Metal cast brass pillar (size 12" high) in silver plated etching suitably with National Safety Awards, logo and year of award 2015 on top in round shape on metal disc in silver plated. Ashoka lion & DGMS logo duly etched with two colours all lacquered mounted on teak wood base with name plate duly etched in colour, all put in one acrylic (transparent fibre) cover & supplied in Hardboard Box [Shield Sample at Page-4] .
3.	Metal cast brass pillar (size 14" high) in gold plated etching suitably with National Safety Awards, logo and year of award 2016 on top in round shape on metal disc in silver plated. Ashoka lion & DGMS logo duly etched with two colours all lacquered mounted on teak wood base with name plate duly etched in colour, all put in one acrylic (transparent fibre) cover & supplied in Hardboard Box [Shield Sample at Page-4] .
4.	Metal cast brass pillar (size 12" high) in silver plated etching suitably with National Safety Awards, logo and year of award 2016 on top in round shape on metal disc in silver plated. Ashoka lion & DGMS logo duly etched with two colours all lacquered mounted on teak wood base with name plate duly etched in colour, all put in one acrylic (transparent fibre) cover & supplied in Hardboard Box [Shield Sample at Page-4] .

The bid shall be submitted through Central Public Procurement (CPP) Portal (www.eprocure.gov.in) mentioning the above-mentioned subject along with No. & date of tender and addressed to **Director General of Mines Safety, Dhanbad, Kind attention - Director of Mines Safety(SOMA), DGMS, Dhanbad – 826 001 (Jharkhand)**. The quotation should reach latest by **5.00 PM on 04.01.2018**.

The bidder shall comply with all terms & conditions mentioned in ***ANNEXURE-I***.

The bids shall be opened on **05.01.2018 at 5:00 PM** from CPP Portal in the presence of the bidders or their authorized representatives, who may like to present.

TERMS & CONDITIONS

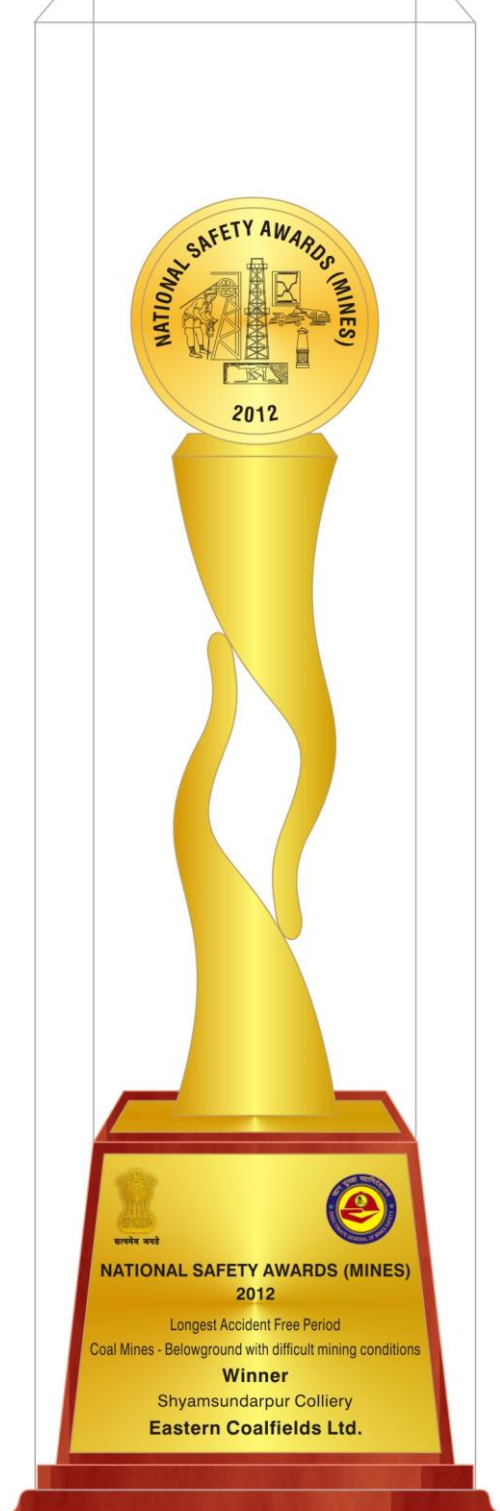
1. No bid shall be entertained which is submitted otherwise than online through Central Public Procurement (CPP) Portal (www.eprocure.gov.in).
2. The bidding shield manufacturing company shall have an annual turnover of more than Rs. 2 crores. The balance sheet of the company shall be submitted along with the bidding document.
3. The Bidder shall have at least 5(five) years' experience of supplying shield to Government Department. Copy of five Work Orders shall be submitted along with the bidding document.
4. Two samples of the shields (one for winner and one for runner) shall be sent on or before 04.01.2018 to this Directorate in the address Director General of Mines Safety, Dhanbad, Kind attention - Director of Mines Safety(SOMA), DGMS, Dhanbad – 826 001 (Jharkhand). After awarding Work Order to the successful bidder, the sample shall be returned to the bidders.
5. The offer should be kept open for acceptance for a period at least 180 days, during the period no higher revision/amendment in prices will be accepted. During the period of validity if however any taxes/duties etc. are imposed/enhanced by Central or State Govt. such taxes/duties will be paid as per rules subject to submission.
6. G.S.T registration number must be mentioned in the bidding document.
7. GST shall be mentioned separately. If GST is not mentioned separately it will be presumed that the price quoted is inclusive of all taxes. Packing/handling charges, if any, should be mentioned separately.
8. Printed conditions of the firm shall not be binding on this Directorate.
9. Quotation received after the expiry of the last date will not be considered in any circumstances.
10. If any one of the material is found defective, it should be replaced by the new one otherwise payment will not be cleared.
11. The shields shall be delivered at New Delhi.
12. For any other information, you may feel free to contact Director of Mines Safety (SOMA), DGMS, Hirapur, Dhanbad – 826 001 (Ph. No. 0326-2221015) before submission of tender.
13. This tender shall be interpreted under Indian Laws.
