

भारत कोष द्वारा ऑनलाइन शुल्क जमा करने के सम्बन्ध में

खनन परीक्षा बोर्ड द्वारा दिए जाने वाले सक्षमता प्रमाण पत्रों के सभी आवेदकों से अनुरोध है की वे अपने आवेदन के साथ दिए जाने वाले निर्धारित शुल्क भारतकोष द्वारा ऑनलाइन जमा करने के दौरान केवल “डी.डी.ओ - 230353” का चयन करें। जिन आवेदकों ने आवेदन शुल्क जमा हेतु डी.डी.ओ के अंतर्गत डी.डी.ओ संख्या: 230359- ALC DHANBAD, 230357- CGIT-CUM-LC DHANBAD, 130361- DIRECTOR.M.S AJMER एवं 130363- JT.DIRECTOR.M.S GOA का चयन किया है वह भुगतान अमान्य है । इन सभी आवेदकों को पुनः “डी.डी.ओ - 230353” का चयन कर शुल्क भरना होगा । जिन आवेदकों ने आवेदन शुल्क जमा हेतु डी.डी.ओ के अंतर्गत डी.डी.ओ संख्या: 130357- DIRECTOR.M.S.E.ZONE SITARAMPUR, 130358- DIRECTOR.M.S.WESTERN ZONE NAGPUR, 130359- DIRECTOR.M.S.S.E.ZONE RANCHI, 103202- Dy. IMPORTANT INFORMATION REGARDING ONLINE FEES PAYMENT THROUGH -
"BHARATKOSH"

All applicants applying for statutory certificates granted by the Board of Mining Examinations are requested to ensure selection of “**230353 – DIRECTORATE GENERAL OF MINES SAFETY (INCLUDING REGIONS)**” as Drawing and Disbursing Office (DDO), while making online fees payment through "BHARATKOSH". Applicants who selected the Drawing and Disbursing Office (D.D.O) as 230359- ALC DHANBAD, 230357- CGIT-CUM-LC DHANBAD, 130361-DIRECTOR.M.S AJMER and 130363- JT.DIRECTOR.M.S GOA are *INVALID* and they have to again pay the stipulated fees by selecting the correct D.D.O. option i.e. **230353 – DIRECTORATE GENERAL OF MINES SAFETY (INCLUDING REGIONS)**. Fees payments of applicants who selected the Drawing and Disbursing Office (D.D.O) as 130357- DIRECTOR. M. S. E. ZONE SITARAMPUR, 130358- DIRECTOR.M.S.WESTERN ZONE NAGPUR, 130359-DIRECTOR.M.S.S.E.ZONE RANCHI, 103202- Dy. Director General of Mines Safety and 230582-PAO (DGMS) DGMS BUILDING DHANBAD shall be acceptable only till 10-03-2019, thereafter only fees paid by selection of Drawing and Disbursing Office (DDO) **230353 – DIRECTORATE GENERAL OF MINES SAFETY (INCLUDING REGIONS)** shall be *VALID* and any fees payment by selection of other Drawing and Disbursing Office (DDO) shall be *INVALID*. Applicant who have made improper fees payments are required to submit the receipt of proper fees payment as per the above guidelines at the earliest to the concerned DGMS office for consideration of their application. This is mandatory for all applications made at any DGMS Zonal/ Regional offices across India.
