**कोविड-19 संक्रमण के महेनजर मध्य अंचल , खान सुरक्षा महानिदेशालय, धनबाद द्वारा आयोजित कनिय खनन परीक्षाओं (माइनिंग सरदार, गैस टेस्टिंग) के दौरान कार्यालय परिसर में अभ्यर्थियों के लिए मानक संचालन प्रक्रिया (S.O.P)**

- 1 Authorization Letter के पृष्ठ भाग में दर्शाए गए **कोविड-19 संक्रमण के सम्बन्ध में परीक्षा के लिए निर्धारित मानक संचालन प्रक्रिया (SOP)** का अनुपालन अनिवार्य है ।
- 2 दफ्तर के प्रवेश द्वार में केवल प्राधिकृत प्रमाण पत्र (Authorization Letter) को दिखाने पर ही अभ्यर्थियों को कार्यालय परिसर में प्रवेश की इजाजत दी जाएगी और उसकी थर्मल स्क्रीनिंग की जायेगी ।
