6. That, You are requested to accept the affidavit for participation of the proceedings of court of Inquiry Raj Mahal Opencast Mines.

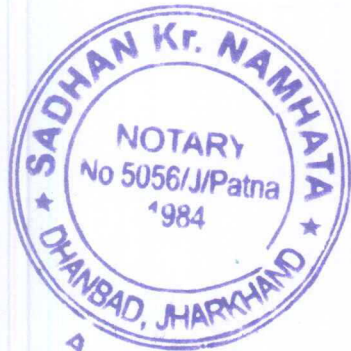
