All officers of DGMS.

**Subject: Generation of Mine Code – reg.**

Sir,

As you are aware that request for the generation of mine code is received from different zones and Regions to the statistical section of HQ, Dhanbad. Subsequent to the allotment of mine codes, the mines are registered on the DGMS web portal. In order to maintain uniformity in the approach in sending request for generation of mine codes from different Zones and Regions, the following points shall be taken care of;

**Change of Ownership of mine –**

**Case – I:** When there is change of Ownership of mine resulting from the transfer of lease or otherwise and the transferred lease is exactly of the same area without any change in mine boundaries.

**Opinion:** There is no need to request for generation of a new mine code.

**Case – II:** When the transferred lease(s) is not exactly of the same area as it was existing earlier but a virgin patch or a working or closed mine is added and no mine code was allotted to the added mine.

**Opinion:** There is no need to request for generation of a new mine code.

**Case – III:** When the transferred lease(s) is not exactly of the same area as it was existing earlier but a working or closed mine(s) /lease(s) is added **completely**, whose existence is known to this Directorate and a mine code has been allotted to it. That is to say that both mine had mine codes earlier but after transfer of leases resulted in completely different mine.

**Opinion:** Then a request for generation of a new mine code may be sent.

**Case – IV:** When the transferred lease(s) is not exactly of the same area as it was existing earlier but a working or closed mine(s) within the lease(s) is added **partially**, whose existence is known to this Directorate and a mine code has been allotted to it.

**Opinion:** Then a request for generation of a new mine code for the mine(s)/lease(s) may be sent as the new mine is completely different from the original mines.

**Case – V:** When the existing lease(s) is transferred to more than one entity for mining.

**Opinion:-** Then a request for generation of a new mine code may be sent for all such resultant lease(s).

**Change of mine boundary –**

**Case – I:** Whenever there is an expansion by way of amalgamation of virgin patch or a mine, working or closed, whose existence is not known to this Directorate and a mine code has not been allotted to it; or contraction in the area of the existing mine boundary.

**Opinion:-** Then there is no need to request for generation of a new mine code.

**Case – II:** Whenever there is an amalgamation, **complete or partial**, of more than one existing mine(s)/lease(s), whether working or closed to which mine codes has been allotted.

**Opinion:** Then a request for generation of new mine code for the mine(s)/lease(s) may be sent as the new mine is completely different from the original mines.

**Re-opening of an abandoned/closed/discontinued mine –**

**Case – I:** Whenever there is re-opening of an abandoned/closed/discontinued mine to which a mine code has been allotted.

**Opinion:** Then there is no need to request for generation of a new mine code.

The above shall be followed while sending request for generation of mine codes to HO. In case of any doubt or clarification on the above or in cases other than those mentioned above, clarification may be sought from HO.

All concerned are requested to strictly adhere to the above instructions.
