

The bidder may visit /enquire/inspect the items before submitting bid, if feel necessary during office hours on the above mentioned date.
3. The condemned items will be disposed to bidder who has quoted/bided for the highest price/rate of all condemned and unserviceable items.

  - iii. The authorization/consent to operate from concerned state Pollution Control Board under Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981.
  - iv. Address proof (Voter ID card/Aadhar card/ Driving License etc) and PAN Number must be enclosed otherwise quotation will not be accepted.
