



3. **Document for date of passing** (for Degree / Diploma candidate only): Final / consolidated mark sheet or provisional certificate etc.
4. **Statutory certificate as per Exam Scheme:**
 - (a) 2nd Class (R/UR) / Overman (R/UR) / Sirdar (R/UR) / Foreman (R/UR) / Mate (R/UR).
 - (b) Gas Testing Certificate (only in case of **Un-restricted** schemes)
5. **Practical Experience Certificate:** For the period mentioned in CBT-2020 application form.
 - (a) For Non-statutory experience (as applicable)
 - (b) For Statutory experience (as applicable)
